

AGL Energy Limited
Win Free Energy for a Year – Victoria & Queensland
Terms and Conditions

1. Information on how to enter forms part of the terms of entry. Entry into the competition is deemed acceptance of these terms and conditions. To opt out contact the Promoter on 1300 656 201.
2. The Promoter is AGL Energy Limited (ABN 74 115 061 375) of 120 Spencer Street, Melbourne VIC 3000, telephone 131 245.
3. Entry is open to all VIC and Queensland residents who are 18 years of age or over. However, employees and contractors of AGL Energy Limited and their immediate families, Salmat IDR, and their associated agencies and companies are not eligible to enter.
4. The Competition commences on Monday 3 October 2011 at 00:01 (AEDT) and concludes on Sunday 4 December 2011 at 23:59 (AEDT). However, the eligibility period for each weekly prize will be as outlined in the below table.

5. The competition will be advertised in Victorian and Queensland press, radio, online and to targeted AGL customers via a direct mail piece sent in paper form to their billing address.
6. To enter, new customers must visit: Victoria agl.com.au/YearFreeEnergy or agl.com.au/OneYearFree or Queensland agl.com.au/365Free or agl.com.au/Free and sign up to an AGL Energy electricity account (worth one entry into the draw) and / or AGL Energy gas account (worth one entry into the draw). New customers acquired through existing AGL sales channels will also be entered into the draws. This includes anyone that signs up online, over the phone, through our field channels (door knockers, OTM) and becomes an AGL customer. Customers who also sign up for paperless billing or sign up to AGL Energy Online will receive one additional entry into the draw for each action taken. New customers who enter the draw will be entitled to a maximum of four entries per site.
7. To enter, existing customers must visit agl.com.au/WinBig and sign up to AGL Energy Online and / or paperless billing and / or AGL Energy Electricity / Gas account (where the electricity or gas account is not already with AGL) and will receive one entry into the draw for each action taken. Existing customers who enter the draw may be entitled to a maximum of three entries per site.
8. The Promoter reserves the right to request winners to provide proof of identity, proof of eligibility to receive the prize in relation to the customer's (residential or business customers') supply address based on occupancy at the nominated supply address and/proof of entry validity in order to claim a prize. Proof of identification, eligibility and entry that is considered

suitable for verification by the Promoter will be determined at the full discretion of the Promoter. In the event that a winner cannot provide suitable proof to the satisfaction of the Promoter, the winner will forfeit the prize in whole and no substitute will be offered.

The Promoter reserves the right to verify the validity of entries and to disqualify any entry of any entrant who tampers with the entry process, who submits an entry that is not in accordance with these Terms & Conditions of Entry or who has, in the opinion of Promoter, engaged in conduct in entering the Promotion which is fraudulent, misleading, deceptive or generally damaging to the goodwill or reputation of the Promotion and/or Promoter. The Promoter reserves the right to disqualify a winner if the Promoter becomes aware that the winner and/or the winner's entry is of a type described in this clause.

The time of each separate entry will be in each case, the time the entrant completes the process in signing up to an AGL Energy plan (gas or electricity), AGL Energy Online or paperless billing. The Promoter accepts no responsibility for any late or misdirected entries due to technical disruptions, network congestion or for any other reason.

12. The sixteen valid entries (one winner in Victoria and one winner in Queensland drawn each week for eight weeks) drawn in the prize draw will win up to one (1) year of energy from AGL (electricity and/or gas) in relation to a specified account at the customer's supply address capped at \$2,200 (GST inclusive) in Victoria and \$2000 (GST inclusive) in Queensland for the first 12 months. The prize will be awarded in a form of an account credit of \$1250 (GST inclusive) in Victoria and \$1350 (GST Inclusive) in Queensland to be applied to the winners' electricity account. If the winner has a gas account they will receive an additional account credit of \$950 (GST inclusive) in Victoria and \$650 (GST Inclusive) in Queensland to be applied to their gas account as relevant. These amounts will appear on the winners' first bill, or bills, after the prize draw and will be used to pay the charges on the account, or accounts, for a period of 12 months or until used up, whichever occurs sooner (**Prize Period**). The Promoter is not responsible for any incorrect or inaccurate information, either caused by the phone user or for any of the equipment or programming associated with or utilised in this competition, or for any technical error, or any combination thereof that may occur in the course of the administration of this competition including any omission, interruption, deletion, defect, delay in operation or transmission, communications line or telephone, mobile or satellite network failure, theft or destruction or unauthorised access to or alteration of entries.

The Promoter reserves the right in its sole discretion to disqualify any individual who the Promoter has reason to believe has breached any of these conditions, or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. AGL Energy Limited, Salmat IDR and their associated agencies and companies assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorised access to, or alteration of entries, and reserves the right to take any action that may be available.
33. If for any reason this competition is not capable of running as planned, including due to infection by computer virus, bugs, tampering, unauthorised intervention, fraud, technical failures or any causes beyond the control of the Promoter, which corrupt or affect the administration, security, fairness or integrity or proper conduct of this promotion, the Promoter reserves the right in its sole discretion to disqualify any individual who tampers with the entry process, take any action that may be available, and to cancel, terminate, modify or suspend the competition, subject to any written direction given under State Regulation.
