The costs set out in this Offer Fact Sheet are indicative costs only. The estimated energy costs below include a **3% discount** off the amount payable for your energy usage. The discount will appear as a separate credit (GST exclusive) on your bills and does not apply, for example, to fixed daily energy service or supply charges, demand usage or AGL Green Choice[™] charges. Calculations assume demand for energy is constant during a full year. Your actual costs may be different from those in this Offer Fact Sheet and will depend on:

- > your actual consumption of electricity and/or gas
- > the pattern of your electricity and/or gas consumption over a full year
- > your actual usage of off-peak electricity (where applicable) and
- > variations in the rates charged by AGL over the term.

The terms for these Energy Plans will provide details on how the rates may vary. The information in this fact sheet applies to Energy Plans which are available at AGL's discretion. If you are interested in entering into one of the Energy Plans please contact AGL to confirm its availability and your eligibility.

When you add one of AGL's Green Choice[™] products to your AGL electricity Energy Plan, AGL will source electricity equal to 10% (Green Spirit), 20% (Green Living) or 100% (AGL Green Energy[®]) of your entire household electricity consumption from renewable energy sources, that are approved under the National GreenPower Accreditation Program.
