AGL Advantage® Online Saver Energy Plans are 24-month fixed-term contracts. AGL may vary the electricity rates with prior written notice.

When you add AGL's Green Energy® option to your AGL Advantage® Online Saver Electricity Plan, AGL will source electricity equal to 100% of your electricity consumption from renewable energy sources that are approved under the National GreenPower Accreditation Program.

Electricity rates

Your electricity rates depend on the type and configuration of your meter. Listed below are the different tariffs that may apply to you. If you are unsure of which rates will apply to you, please contact us on **133 835**.

- > Off-peak Controlled Load (Tariff 116) is available in conjunction with tariffs 126, 126M, 128 and 128M.
- > The kWh values under all of the usage headings below and overleaf are annual consumption thresholds up to which the stated price may apply. Billing period consumption thresholds for the stated price are calculated by dividing the annual threshold by 365 and multiplying by the number of days in the billing period. Unused amounts for each billing period consumption threshold are not carried forward.
