Eligibility

- This AGL The Good Guys Offer is only available to The Good Guys customers (also referred to as "you" or "your") in Vic, NSW, Qld, SA and WA, with selected AGL Energy Plans, via the dedicated AGL The Good Guys product landing page or by calling AGL on 1300 769 182 and quoting The Good Guys Offer (Eligible AGL Energy Plan).
- 2. Offer only available to residential customers in areas where AGL operates.
- 3. Offer not available when connecting a home to the electricity or gas network for the first time (also referred to as a New Connection).
- 4. Customers will not be eligible to receive this Offer if they cancel their eligible AGL Energy Plan before the end of their first billing cycle or before paying their first energy bill on the Plan.

- 12. The Good Guys Digital Gift Card can only be used on purchases in The Good Guys stores or on The Good Guys website.
- 13. The Gift Card will be issued at the end of your first full billing cycle and once you pay your first energy bill on your Eligible AGL Energy Plan, after any credits on your account have been used up.
- 14. To redeem your The Good Guys Digital Gift Card, you will first be sent an activation email with instructions. You will need to follow the prompts in the email to confirm your preferred mobile number online. Next, you'll receive an SMS with a link. Before using the Gift Card, you must first activate it through the link sent via SMS and follow the instructions which will require you to download the Vault app and accept the terms and conditions. The Gift Card must be activated prior to use and expiry.
- 15. Any ancillary costs associated with redeeming the Good Guys Digital Gift Card are not included. For the avoidance of doubt, there are no post-supply fees prohibited by the Australian Consumer Law associated with redeeming the Gift Card.
- 16. Once activated, you will be able to add The Good Guys Digital Gift Card to your digital wallet on your smartphone device.
- 17. The Good Guys Digital Gift Card will be valid for 36 months from the date of issue. At the expiry of the Gift Card, any unused balance will be forfeited. You will not receive notice prior to expiry.
- 18. The Gift Card expiry and balance can be found on your mobile device in the Vault App.
