18-6.1	<b>Site Induction</b> MR - The new access road to the site is in, but is still under construction, all members were asked to drive carefully, especially in the wet today. Site amenities and emergency response plans were advised to all members.

AGL now holds no Dangerous Goods licences. The Butane tank has been removed.</p> <p>AC - URS has been appointed to assist AGL with writing the Annual Environmental Performance Report. This report is now in final draft stage.</p> <p>AC - Quarterly noise monitoring at the RPGP site has been undertaken and all results were compliant with the inclusion of additional compressors operating.</p> <p>AC - Quarterly air emissions are being monitored at RPGP.</p> <p>AC - Annual Returns Report has been submitted to the DECC for RBTP licence.</p>		
<p>18-6.9</p> <p>18-6.10</p> <p>18-6.11</p> <p>18-6.12</p> <p>18-6.13</p> <p>18-6.14</p>	<p><b>Operations</b></p> <p>MR - The RPGP access road is 95% complete. 2200 native trees have been planted along the road and the grass is growing. This will leave a nice professional and safe access for the AGL entrance.</p> <p>MR - AGL has continued drilling 4 more wells and 2 core hole wells. We are onto our 3<sup>rd</sup> horizontal well and will continue drilling next year.</p> <p>MR - We have completed a 17 well frac campaign this year, and will finish 2-3 wells in late January. This has been undertaken incident free.</p> <p>MR - AGL has completed the initial site rehabilitation for 5 EMAI well sites.</p> <p>MR - An in house gas gathering line rehabilitation audit for EM and RB wells has been undertaken.</p> <p>MR - AGL has commenced a 12 month Safe Driving Program with all staff including workshop seminars, risk assessment for driving on private and public roads, and AGL is being assisted with this by</p>		

	the Driving Institute of Australia.		
18-6.15	MR – An employee was involved in a serious motor vehicle accident this week. A contributing factor appears to be diesel on the road.		
18-6.16	MR – Extensive safety training courses are being undertaken in HSE Management Systems, including OH&S Risk Management, Manual Handling, WorkCover Underground and Overhead Utilities.		
18-6.17	MR – With the Equine Influenza quarantine requirements, all AGL vehicles undertake a disinfectant wash down of rims and wheel arches prior to accessing properties. Spray stations have been set up at access points to properties and foot baths are also available on some properties. Disinfectant hand wash is also available in each vehicle for staff use prior to entering and when leaving each property. AGL has a Safety is First Culture.
