Land & Approvals – Recent Developments

- > AGL have reviewed the Mining SEPP. Under the Mining SEPP, the Camden North Expansion project cannot proceed in its current form.
 - » the Camden North Expansion Project remains suspended.

- > AGL is well aware of NSW's gas demand, and the gas shortages likely to be faced in the coming years.

Field operations

- > No CSG Drilling since September 2012.
- > Well workovers undertaken in Menangle Park and Mt Taurus fields.
- > Next well workovers in Qld.
- > 3 water monitoring bores drilled at Glenlee/ Menangle Park in January and February to depths of approx 100m, 150m, and 300m

> Noise monitoring

- » December 2013 and March 2014 quarterly monitoring results compliant
- » Noise monitoring surrounding Spring Farm (SF20) wells confirmed compliance with project noise criteria.

> Air emissions monitoring

- » December 2013 and March 2014 quarterly monitoring results compliant
- » January, February and April 2014 monthly monitoring results compliant
