Land & Approvals – Recent Developments

Policy

- › **NSW Mining SEPP** – Awaiting announcement.
- › **NSW Planning Act White Paper**- Currently on exhibition
- › **EPBC Amendment Bill** – New water trigger introduced. Federal assessment and approval required for coal seam gas and large coal mining developments.
- › **Petroleum (Onshore) Amendment Act** – Currently listed for debate in the upper house

Water Monitoring

- › Installation of 4 monitoring bores at Harness Racing completed, as part of the commitment for increased water monitoring.
- › Installation of 1 additional water monitoring bore at Denham Court.
- › 3 monitoring bores to be installed at Currans Hill location.

Field operations

- › No Drilling since September 2012.
- › Well workovers undertaken in Menangle Park, Razorback, Mt Taurus, Spring Farm fields
- › Next well workovers in Menangle Park and Spring Farm fields
- › Menangle Park 25 further rehabilitated.
- › Minor earthworks to maintain internal access roads.
