Land & Approvals – Recent Developments

Policy

- > NSW Mining SEPP Awaiting announcement.
- > NSW Mining SEPP state significant resources amendment proposed.
- > NSW Planning Act White Paper- submissions made; being analysed
- EPBC Amendment Bill New water trigger introduced. Federal assessment and approval required for coal seam gas and large coal mining developments.
- > Petroleum (Onshore) Amendment Act Listed for debate in the upper house
- > Enforceable Undertaking
 - » Signed by AGL on 07 August 2013.
 - » By signing the EU, AGL has made a number of undertakings to the EPA.
 - » AGL has paid UWS \$150,000 for "Love your Lagoons: Place based learning and environmental action in South-Western Sydney Project".

Health, Safety and Environment


- > Fugitive emissions monitoring completed across 25 locations. Report currently being reviewed and will be publicly released in late 2013.
- > 2012-13 Annual Environmental Performance Report currently being prepared. Report to be released next month.
- > 2010-12 Independent Environmental Audit now available via AGL Camden microsite.
- > Environmental Health Impact Assessment for the Northern Expansion project currently being finalised. Report to be released next month.

Field operations

- > No Drilling since September 2012.
- Well workovers undertaken in Spring Farm, Menangle Park and Wandinong, Razorback, Mt Taurus, Spring Farm fields.
- > Next well workovers in Menangle Park field.
- > Menangle Park 25 further rehabilitated, including planting of 700 native trees.
- > Minor earthworks to maintain internal access roads.







Rosalind Park Gas Plant

- > Quarterly noise monitoring
 - » Conducted in July and this week
 - » July results compliant
 - » September results yet to be received
 - » Next scheduled for December
- > Quarterly air emissions monitoring
 - » Conducted this week.
 - » Results will be uploaded to www.agl.com.au



Continuous Emissions Monitoring

- NOx exceedance recorded on Compressor 1 in August. Details of the exceedance are included in the August 2013 CEMS report.
 - » The three hour exceedance (13 August) was caused by a cracked engine mount which increased engine vibration and caused the compressor engine to run rich and increase NOx.
 - » A configuration error by the CEMS supplier caused the RPGP SCADA to display lower NOx levels, which resulted in the High NOx alarm not being triggered.
 - » AGL first became aware of the NOx exceedance on 05 September.
 - » A number of corrective actions have been implemented including repairs to the cracked engine mount, correction of configuration error, additional RATA testing, lowering High NOx alarms, and increased reporting requirements for the service provider to AGL.
 - » An incident investigation report has been submitted to the EPA.
- > EPA issued a PIN to AGL (11 July 2013) for failing to upload CEMS monitoring reports within 14 days. All reports are available at www.agl.com.au
