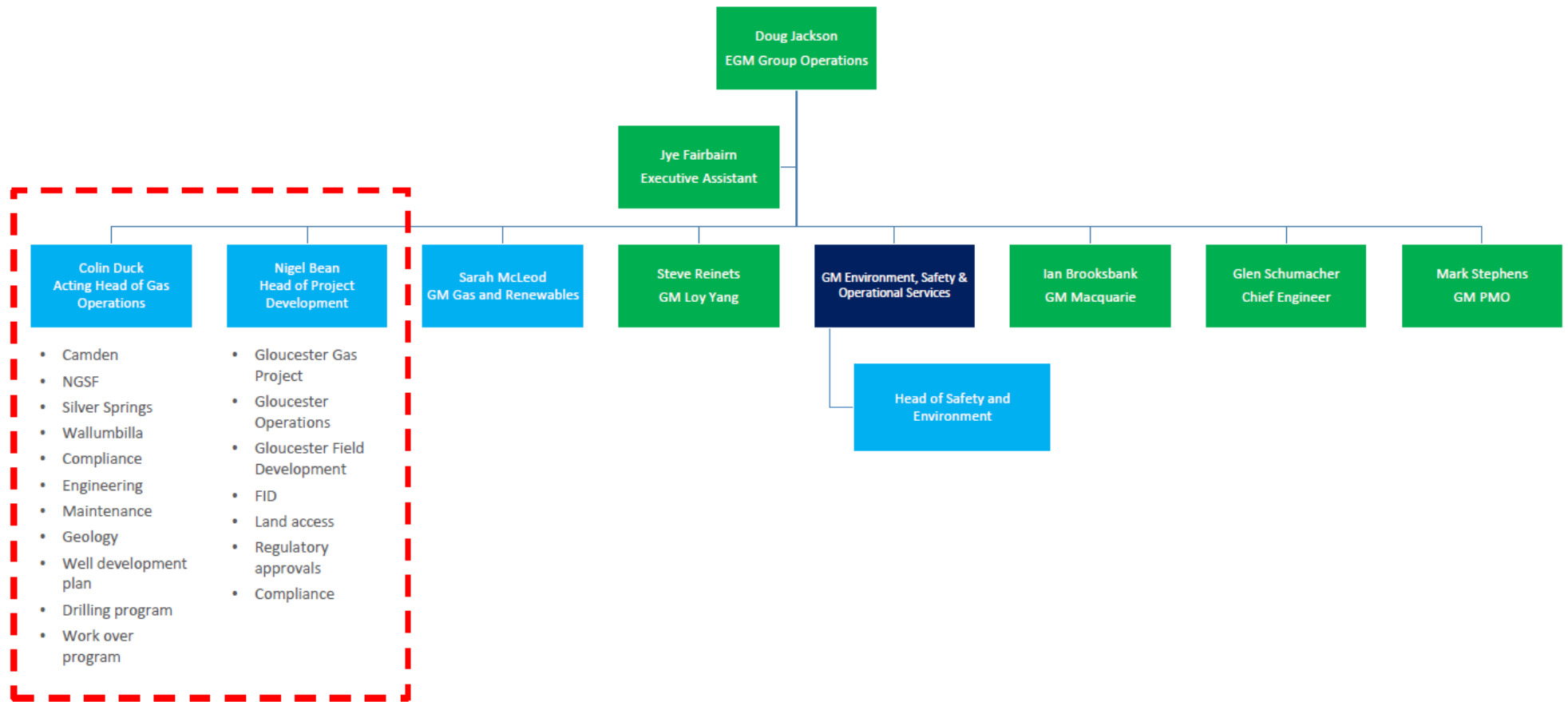

AGL Business Update.

- Following a comprehensive review of the Upstream Gas business, AGL announced it would focus on core gas projects and divest non-core and under-performing gas assets and activities.
- Core projects to be retained will sit under Group Operations – Gas Operations and include:
 - Camden Gas Project
 - Newcastle Gas Storage Facility
 - Silver Springs underground storage facility and Wallumbilla LPG Plant.
- AGL will no longer proceed with the proposed Camden Northern Expansion Project, which has been on hold since February 2013.
- These changes will provide efficiencies, driving productivity and leveraging expertise providing residential and business customers with competitively priced gas.

- Sold back PEL 2 to government as part of NSW Government PEL buy-back scheme.
- Northern Expansion Project not progressing.
- Landholder engagement for well plug and abandonments.
