Operations & Environment

Compliance Monitoring

- RGP **quarterly noise monitoring** was completed in September and December. All results were compliant with noise limits. No noise complaints were received during the last quarter.
- RGP **quarterly air emissions monitoring** was completed in September and November. All results were compliant with air emission concentration limits.
- **Annual Leak Detection and Repair Report** was issued and a summary report was uploaded to the CGP website [here](#). Seven leaks were detected and repaired within the target period recommended in EPL 12003.
- **2017-18 Annual Environmental Performance Report** was finalised on 02 November 2018 and uploaded to the CGP website [here](#).
- Treo Environment commenced the **2015-2018 Independent Environmental Audit** on 07 November 2018. The Audit Report is currently being finalised and will be issued to the CCC in January 2019.
- AGL has engaged Biosis Pty Ltd to undertake an **Aboriginal Cultural Heritage Assessment** on proposed upgrades to existing internal access roads on the Wandinong property, Menangle. Biosis is assisting AGL in consulting with the Aboriginal community and will follow the *Aboriginal cultural heritage consultation requirements for proponents 2010* (DECCW 2010). The project will be undertaken in accordance with the *National Parks and Wildlife Act 1974*.

Decommissioning & Rehabilitation

AGL proposed to decommission 17 sites known as Stage-1 of the Camden Rehabilitation Project during 2017/2018. During that time, AGL has completed all workover rig activities associated with decommissioning 19 wells. Since the September CCC meeting, the AGL workover rig has completed rig activities associated with decommissioning the following wells with Elizabeth Macarthur 33 awaiting cut & cap scheduled in early 2019:

- Elizabeth Macarthur 31
- Elizabeth Macarthur 32
- Elizabeth Macarthur 33

The workover rig is currently shut-down for the Christmas break and will recommence works on 21 January 2019.

The NSW EPA Gas Regulation Branch and NSW Department of Planning and Environment – Resources Regulator continue oversight and inspections of AGL’s decommissioning and rehabilitation activities to ensure they are completed safely and in accordance with regulatory conditions applying to the project.

Since September 2018, the EPA has inspected and provided confirmation that five additional wells have been rehabilitated in compliance with AGL’s regulatory requirements. Four of these (EM16, RP06, RP10 and RP11) were decommissioned and fully rehabilitated. The other one (GL16) is co-located (shared site) with a well that continues to produce gas, and as such has been decommissioned and partially rehabilitated, allowing continued access to the adjacent producing well.

Next steps:

AGL intends to decommission a small number of wells in 2019 as they reach end of their producing life. The majority of wells will continue to produce until closure of the Camden Gas Project in 2023. Workover maintenance of producing wells will take priority to ensure gas production continues for NSW domestic, manufacturing and business customers during the production phase of the project.

Landowners

AGL continues to regularly communicate with landowners regarding access to well sites for planned workover maintenance and decommissioning activities on the land. Consultation is also occurring regarding surface rehabilitation of well sites once decommissioning of the well is complete.

Youth Solutions is excited to announce that we have secured funding under the AGL Local Community Investment Program for 2018!

The grant will be used to produce a new Drive SAFE animation and supporting program resources. AGL Business Update

On 18 December 2018, AGL announced that the Board has appointed Brett Redman as Chief Executive Officer & Managing Director on a permanent basis. Mr Redman has been AGL's interim CEO since 24 August 2018 and was previously Chief Financial Officer. The appointment is effective 1 January 2019.

AGL Chairman, Graeme Hunt, said: "Brett's appointment follows a domestic and international search process that included strong internal and external candidates, as a result of which the Board formed a unanimous view that Brett is the right person to lead AGL in the years ahead.

"Having had the opportunity to work with Brett during his four months as interim CEO, the Board has been greatly impressed with the manner in which he has led the business. He has demonstrated an energy and rigour and a commitment to culture and performance that has been welcomed by all."

Mr Redman said: "It's a great honour for me to get the opportunity to represent AGL's people as CEO on a permanent basis. We have strong momentum with our commitments to safety, our customers, our people and our financial performance. The team is focused on driving growth, to the ongoing transformation of our business and to investing in our social licence at a time of immense scrutiny in our sector."

Mr Redman was AGL's CFO from 2012, having joined AGL in 2007 and has more than 25 years' experience in senior roles in blue-chip industrial companies in Australia and North America.

A fun fact about Brett is that he is from Camden and still has family living in the local area.
