Operations & Environment

Compliance Monitoring

- RPGP **quarterly noise monitoring** was completed in May. All results were compliant with noise limits. No noise complaints were received during the last quarter.
- Well workover **noise monitoring** was completed during workover activities at Spring Farm and Menangle Park. All results were compliant with noise goals.
- RPGP **quarterly air emissions monitoring** was completed in May and June. Final results are yet to be received.
- The annual review and update of the **Environmental Management Plan and Sub Plans** was completed. The latest versions are available on the <u>Camden Gas Project website</u>.
- AGL has engaged Biosis Pty Ltd to undertake an **Aboriginal Cultural Heritage Assessment** on proposed upgrades to existing internal access roads on the Wandinong property, Menangle. Biosis is assisting AGL in consulting with the Aboriginal community and will follow the *Aboriginal cultural heritage consultation requirements for proponents 2010* (DECCW 2010). The project will be undertaken in accordance with the *National Parks and Wildlife Act 1974*.



Decommissioning & Rehabilitation

AGL will keep decommissioning wells in 2019 as they reach end of their producing life. Maintenance of producing wells is taking priority to ensure gas production continues for NSW domestic, manufacturing and business customers.

AGL continues to work with the NSW EPA Gas Regulation Branch and NSW Department of Planning and Environment – Resources Regulator to ensure the maintenance, decommissioning and rehabilitation activities are completed safely and in accordance with regulatory conditions.

In March 2019, AGL commenced decommissioning activities at Menangle Park 05 (MP05) well. The EPA inspected and provided confirmation that three additional wells – Lipscome 01 (LP01), Mount Taurus 05 (MT05) and Wandinong 06 (WG06) – were decommissioned and rehabilitated in compliance with AGL's regulatory requirements. These sites have been returned to the landowners.
