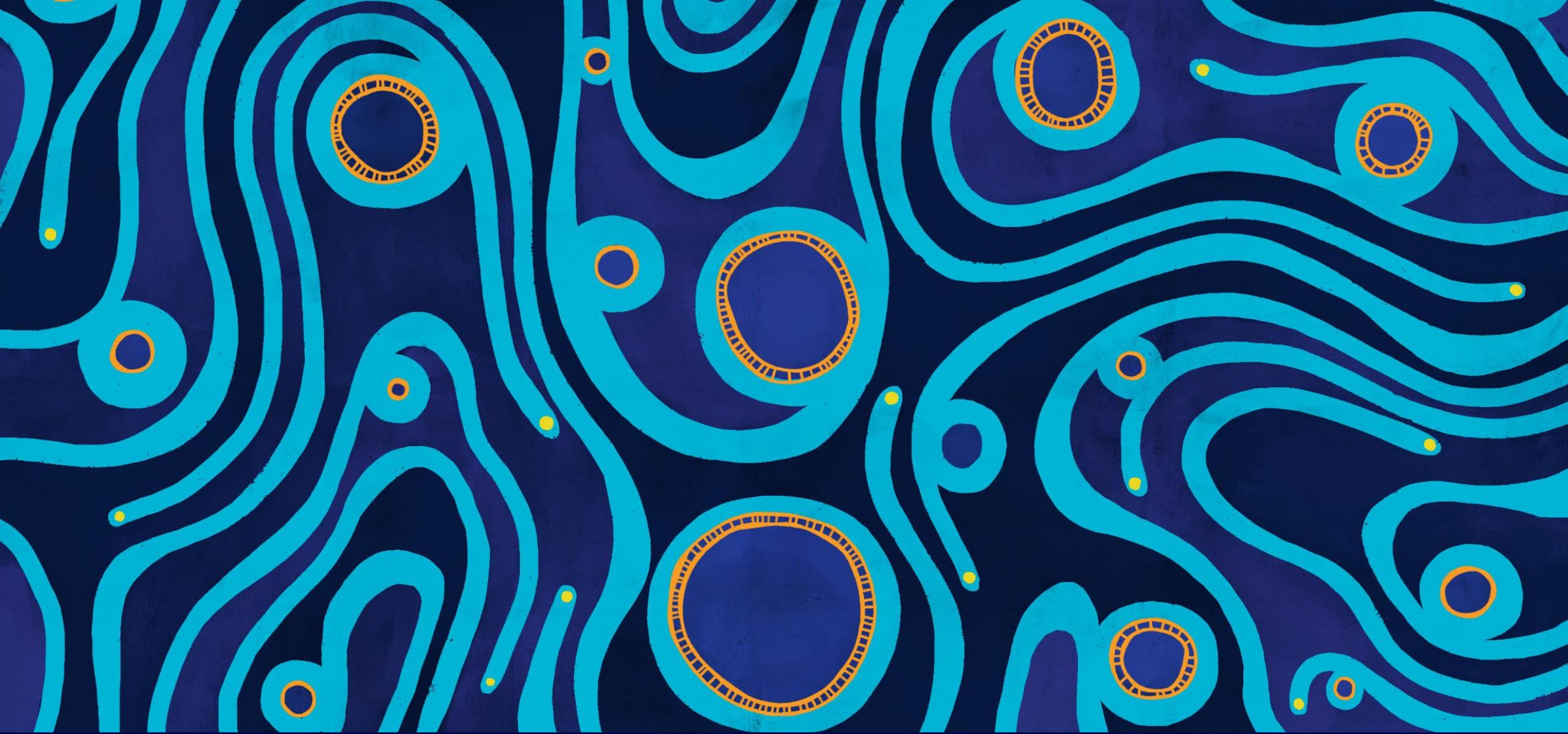


Newcastle Community Dialogue Group

NGSF Update – this period

- No major incident, MTIs or LTIs
- Major projects implemented including FW system, ethylene loading, etc.
- Liquefaction season started
- Liquefied 600 TJ gas since September
- NSW SafeWork audit carried out – minor scaffolding issues identified and rectified
- New Safety Case commenced – license to be renewed in 2027



Environment update - NGSF

- Annual environmental return was submitted
 - Statement of compliance with licence
 - Pollution fee calculation (emissions)
 - Test of pollution incident response plan
- Water monitoring completed (6 monthly) - awaiting report
- Bushfire preparedness completed – ember attack
- Mock drill
 - Bushfire evacuation to test operator knowledge of tertiary escape paths
- Zero environmental incidents in this quarter



Environment update cont...

- Medowie Offset Property
 - Annual report submitted to the Biodiversity Conservation Trust
- Currently in Year 10 of property management
- No issues experienced at the property in the last quarter
- Rehab area is progressing well
 - *Angophora costata* (Smooth barked apple)
 - *Eucalyptus piperita* (Sydney Peppermint)

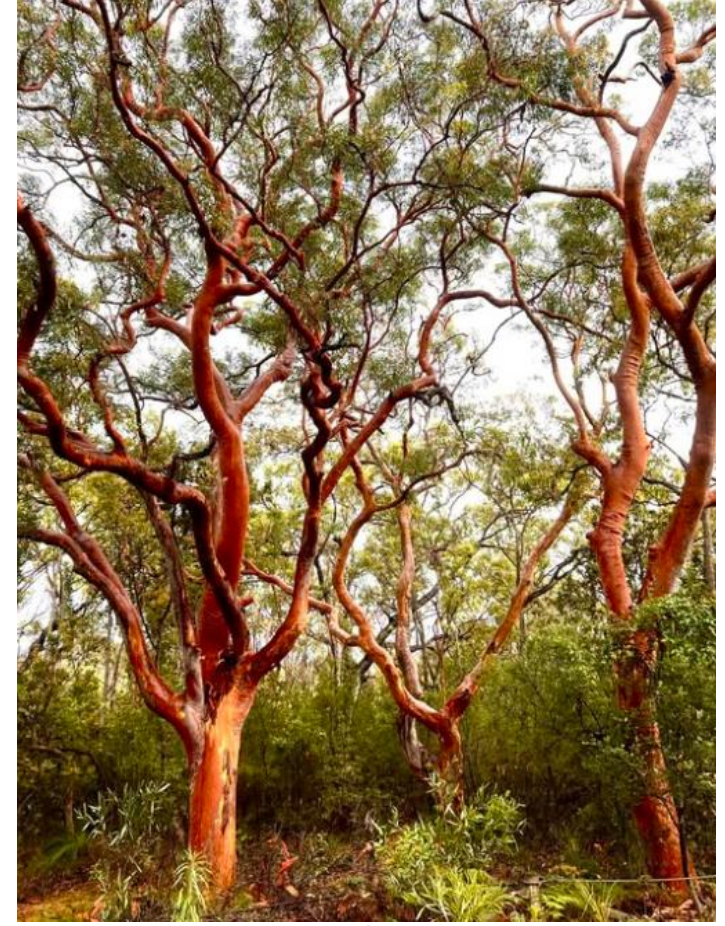

Sodium fluoroacetate (1080 poison)

- 1080 is used to bait wild dogs
- It is a restricted use pesticide, available to authorised and trained users under APVMA licensing
- Only pre-mixed baits can be used (e.g. meat)
- Safety protocols must be followed including how the bait is presented and managed, notifications to landholders etc
- Impacts on native animals are possible (e.g. secondary poisoning)
- While Cool Burn has been involved with the site, we have not used baiting because there is no evidence that wild dogs/dingoes need to be controlled

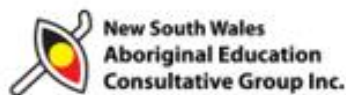

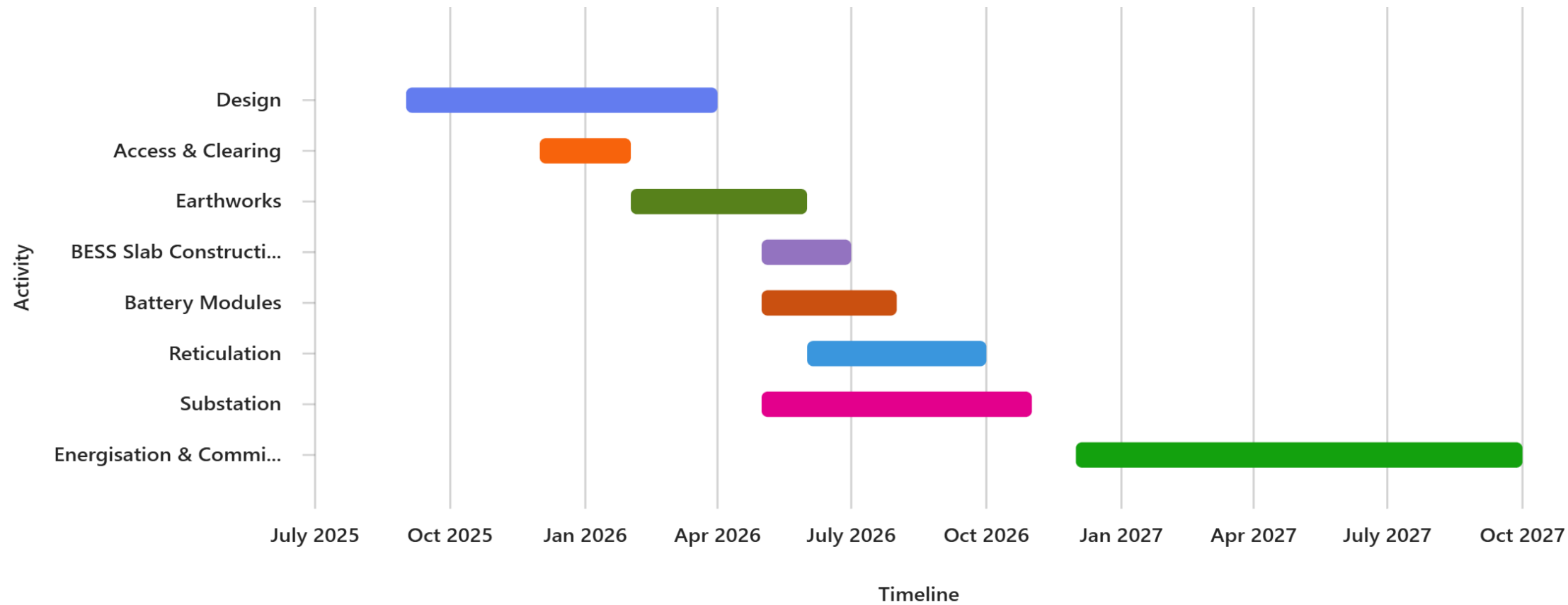

Introduction of a *First Nations' and Regional Development Specialist*:

Amy Pocock-Polson

As the First Nations' and Regional Development Specialist, Amy is responsible for embedding First Nations engagement and regional development outcomes across the Construction portfolio in the Hunter Region. She is working closely with project teams, Traditional Owner groups, First Nations' and regional Stakeholders and businesses to ensure that construction activities support inclusive, sustainable, and culturally respectful development.

Targets for the Construction phase include:

- Engagement of Indigenous Businesses engaged to deliver part of the Work as % of contract value,
- % of FTE roles undertaken by Aboriginal and/or Torres Strait Islanders
- % of Contract Value is contracted to local businesses based in the Hunter- Central Coast Renewable Energy Zone and adjacent local government areas.

Current strategies include:

- Weekly engagement meetings with EPC Contractor (Fluence) to align procurement and development strategies with AGL's First Nations and regional commitments.
- Local employment partnerships to design and implement:
 - Pre-employment training programs
 - Apprenticeship and traineeship programs
 - Targeted recruitment campaigns that address the workforce requirements of underrepresented group ie. Women in Construction, First Nations' employees and Long-Term Unemployed.
- Maintaining, reviewing and meeting with First Nations and regional businesses from AGL's Tomago BESS Expressions of Interest forms within the Renewable Energy Zone.
- Facilitating direct introductions between Fluence and the local businesses and employment services to secure works packages.
- Identifying businesses who could benefit from AGL's Capability Development Fund, First Nations Capability Fund, and Supply Chain Innovation Fund to prepare these businesses for participation in major projects.

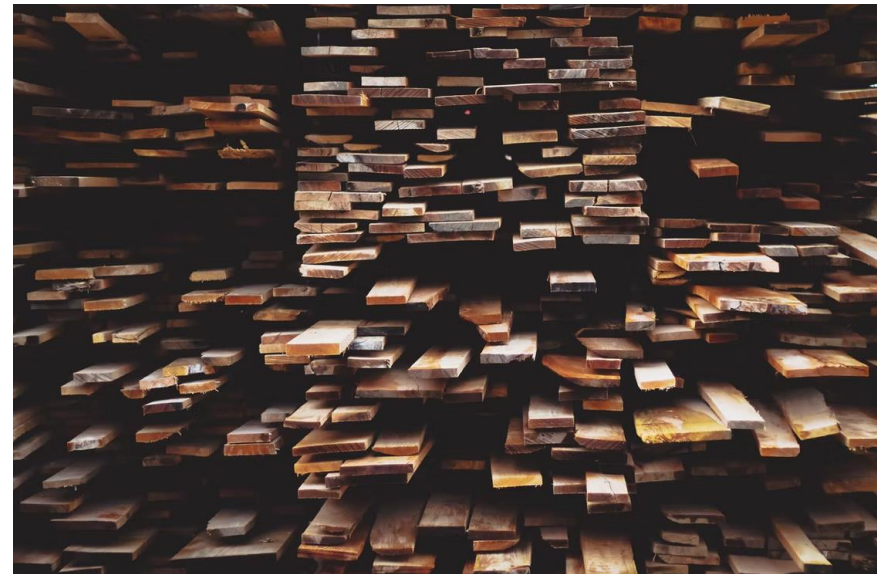

AGL partners with Guppur Men and Youth Shed

In October, Justin Ridgeway, Aboriginal Elder of the Worimi people and of the Murrook Cultural Centre along with Raymond McMillan of The Worimi Green Team visited the Tomago BESS site to identify and mark trees suitable for timber collection. The timber will be repurposed for the Guparr Men and Youth Shed, where Justin leads cultural education programs and teaching community members traditional skills such as crafting tools and weapons. We are hopeful that this initiative will strengthen cultural heritage, support on-country learning, and build a positive engagement between the project and the Worimi community.
