For example, when we arrange on your behalf for a service to be performed by the Distributor (who is responsible for the electricity poles and wires, gas pipes and meters in your area) or Meter Service Provider (who is responsible for the meter).

Effective 1 July 2026 for Electricity. Effective 1 February 2026 for Gas. Fees are subject to change. Any increase to these fees will only occur in July each year. If your fees are increased, we will provide at least five business days' notice.
