Uber One 12-Month 50% Discount Membership Offer for AGL Customers – Terms and Conditions

Eligibility

1. The Uber One 12-Month 50% Discount Membership Offer (**'Uber Offer'**) is available to Eligible Customers, being:
 - a. existing residential AGL customers (also referred to in these Terms as “you” or “your”);
 - b. with a residential Supply Address located in in Victoria, New South Wales, Queensland, South Australia and Western Australia (in areas where AGL operates); and
 - c. to whom AGL makes available a one-time Uber Redemption Code (**'Uber Code'**).
2. The Uber Offer is made available specifically to the Eligible Customer and is not transferrable or assignment to any other person.
3. To redeem the benefits available under the Uber Offer, Eligible Customers must have an Uber One Membership.
4. The Uber Offer is available to Eligible Customers from 1 June 2026 to 30 May 2027 unless extended, varied or removed by AGL prior to this date.

5. Eligible Customers who redeem the Uber Code according to the instructions provided by AGL at the time of providing the Uber Code are entitled to receive an Uber One Annual Plan Membership at a discount of 50% off the standard annual price of an Uber One Annual Plan Membership for a period of twelve (12) months from the date on which the Uber Code is redeemed.
6. At the expiry of twelve (12) months from the date on which the Uber Code is redeemed, the Eligible Customer will be charged monthly at \$9.99 or the then standard monthly price of an Uber One Membership in Australia and via the Eligible Customer’s selected payment method, unless cancelled by the customer:
 - a. via the Uber app any time up until 48 hours before the billing date; or
 - b. by contacting Uber Support any time before the billing date.
7. If you cancel less than 48 hours before your next renewal day, you may see a charge that will be automatically refunded.
8. Uber will send prior notice of the upcoming expiry of the Uber Offer to the Eligible Customer via the contact details nominated for the relevant Uber One Membership at least 7 days prior to the expiry of the Uber Offer.

Uber One Membership

9. Your Uber One Membership is governed by a separate agreement between you and Uber, including but not limited to the [Renewable Membership Terms and Conditions](#).

AGL and Uber reserve the right to revoke or withdraw the Offer if either AGL or Uber suspects a breach of these Terms and Conditions, Uber's Terms & Conditions, or if either AGL or Uber reasonably suspect any suspicious or fraudulent behaviour associated with your participation in the Uber Offer.
14. Eligible AGL Plans are solely supplied by AGL and you're required to contact AGL directly for more information about energy or telecommunications plans. Uber is not authorised to negotiate or sell energy or telecommunications plans on behalf of AGL.
